FOLLOWING RECEIVED FROM RELIABLE SOURCE OF FBI, MIAMI: ROLANDO O T E R O (201-284811) (BORN 18 APREIL 41, MARIANAO, HAVANA, CUBA; BAY OF PIGS VETERAN, NATURALIZED U.S. CITIZEN LIVING MIAMI, MEMBER OF MIAMI PARACHUTING GROUP KNOWN AS "GOLDEN FALCONSO -- COMPRISED MAINLY OF CUBAN EXILES--LED BY CUBAN EXILE NAMED FRANK CASTRO. A LEADER OF THE FRENTE DE LIBERACION NACIONAL DE CUBA (FLNC), WHO CURRENTLY LIVING IN DOMINICAN REPUBLIC, VISITED FRANK CASTRO IN. DOMINICAN REPUBLIC FOR TWO DAYS IN EARLY MAY 75.
