 New York Daily News, LA/COG was asked to do a file check to determine whether Subject was ever connected with the Agency. According to a EA/COG Dest energy IP trace; CI/OA and Security Office check, LARINZ has never been employed by the Agency. Of interest, however, is the fact that her sister, Val eric LORINZ, was granted a CSC on 14 July 1955; initiated by Finance Division, as a witting employee. At that time Valerie was an employee of the National Pank of Washington.
- 2. There are several references, sourced to the FBI and DCD.

 LORENZ is a self-admitted former girl friend of Fidel CASIRO. She claims that she met Fidel while on a trip to Cuba with her father. Because of the bad abortion operation performed on LORENZ in Cuba in September 1959, LORENZ was-operated on by a Dr. Hanniar on 20 January 1960 at the Roosevelt Hospital in New York City.

A 24 April 1961 FBI document states that on 8 January 1961 LORENZ, STURGIS, Alex RORKE were to meet that evening and attempt a unity meeting of anti-Castro Oubans. 1. According to a source of the Miami Field Office of the Domestic Collection Division, Subject disclosed to the source the following information concerning plans which allegedly reflect Subject's interest in Africa and Canama in conversations held on or around 5 June 1977. Subject has discussed plans to establish a Cuban Government in exile on Angolan soil with the help of Holden ROBERTO, FNLA. Subject is prepared on receipt of agreement from Roberto to provide food, medical teams and other forms of assistance to the FNLA. Ostensibly, this would be a first step fellowing recognition by Roberto of a Cuban Exile Government. This government would then attempt to raise troops and, among other things, capture as many Castro soldiers as possible in order to use them as an exchange or trade instrument. The funds for such an enterprise ostensibly would come from Cuban Communities in Brazil, Nicaragua, Panama, Mexico, Venezuela and the United States. One aspect of the proposed unconventional war is the use of counterfeit Angolan money. Also allegedly involved is planning to secure Angolan aid for Panamanians who oppose Torrijos.

1. The following information was provided to by his DCD Miami office on 23 August. The information was given to the DCD Miami office by a contact (not identified) on 23 August who obtained it from Oscar FREELY. FREELY is writing a book on Frank STURGIS.

2. STURGIS is to appear on the Tomorrow Show at 2 a.m. on 24 August, which is to be narrated by Tom Schneider. STURGIS just recently returned to Minmi from taping the show in New York.

- While in New York STURGIS saw Marita LORENZ and obtained from her a book which, according to source, appeared to be cryptographic material and seemed to relate to Albania. The DCD source saw a "few copies" of what he described as "mathematical matrix" material.
- STURGIS currently (today 23 August) is attempting to contact Senator Bakor to turn over the material to him. DCD plans to ask the source to monitor the situation and advise whether the material in fact is turned over to Baker.

1. This morning I received a phone call from the COS, Miami who advised me that yesterday Frank Sturgis called the DCD, Miami Office, and expressed a desire to meet with one of the DCD officers. Sturgis claimed to have new information on the movement of narcotics through Mexico and other information which he did not specify.

The DCD Miami Office thanked Sturgis for calling and referred him to the FBI and DEA, who would be the most interested recipients of the information he has. Sturgis was very pleasant on the telephone and the DCD people obviously responded correctly.

CUBANOS INTROS (UNITED CUBANS) INTERNAL SECURITY - CUBA NEUTRALITY MATTERS - CUBA

Cubanos Unidos (CU) is a Cuban exile anti-FIDEL CASTRO organization in Niami, Plorida. Its purpose is to unite all exile groups into a unity organization and begin military operations against the present Government of Cuba.

WILFREDO NAVARRO DEATO is the head of CU. which organization now maintains office space at 1996 S. W. 1st Street, Miami, telephone 642-9741.

On June 9, 1970, MM T-1, a Cuban exile involved in revolutionary matters for the past six years, advised that CU recently decided to start selling bonds issued. in the name of the Republic of Cuba. The money collected would be used to purchase arms for proposed military operations against Cuba.

On June 15, 1970, MM T-1 stated that WILFREDO NAVARRO at that time was claiming that MAURICE FERRE. member of the Miami City Commission, is assisting him it Cuban revolutionary activities. NAVARRO claimed that about a wock previously, a meeting was held in the PERRE. Building in Midmi, and it was determined that CU had adequate money resources. NAVARRO said that he instructed TOMAS ARENCIBIA. a leading member of CU, to ouit his job and NAVARRO would pay his salary. NAVARRO explained that he wanted ARECIBIA to work on a full-time basin for CU. Also present at this meeting were three unidentified Amoricans, one of whom reportedly has a quantity of arms stored at his house.

On June 19, 1970, NM T-3, another Government agency which conducts intelligence investigations, advised information had been received that GU recently held a meeting to introduce Americans who are backing their organization. The Americans were FRANK FIORINI and ED KAISER. FIORINI calls himself the "Chief of Intelligence Section of Cubanos Unidos",

On July 1, 1970, WHIREDO NAVARRO BEATO appeared at the Blami Office of the FBI with his brother, ROFRME NAVARRO BEATO, and advised as follows:

FRANK FIORINI. an American citizen who has been involved in Cuban exile revolutionary matters for the past ten years, recently signed a unity agreement with CU. In this agreement, FIORINI, who represents some independent anti-CASTRO organization, agreed that political unity of all exile groups must be established. FIORINI is not a member of CU as such, holds no official position, and is not in charge of intelligence.

NAVARRO said that a few days previously he returned from Washington, D. C., where again he was trying to obtain United States Covernment support and backing. He was told that no support could be given unless it was personally authorized by President RICHARD M. NIXON.

They stated that JONGE CONZALEZ, also known as "Rombillo", who was formerly associated with another anti-CASTRO organization, was in no way associated with CU. They claimed that CU had no plans to attack a Russian vessel off the coast of Florida. CU had previously said it needed some 57mm recoilless rifles for this purpose but had no intention of attacking a Russian vessel. Announcements that they were going to do so were made for political propaganda and also to stir patriotic Cuban exiles to become more active in Cuban revolutionary matters.

BOB RAMEY (phonetic), a commentator on Channel 4 TV, Migni, who will travel with WILFREDO NAVARRO.

(First Name Unknown) RODRIGUEZ ALONSO, designated Military Chief of CU.

MAURICIO FERRE, reportedly provides financial backing to WILFREDO NAVARRO.

PILIN MENDOZA, a friend of JOSE PERRE.

MM T-5 indicated that it was intended that mercenaries from Corsica would be used.

On July 29, 1970, EDWIN BENJAMIN KAISER, JR., 805
West 30th Street, Hialcah, Florida, advised that he knew no
one named BOB RAMEY or (First Yane Unknown) RODRIGUEZ ALONSO.
KAISER said that he had previously been in the French Foreign
Legion and knows former legionnaires who now live in all
parts of the world. Many of these legionnaires would fight
as mercenaries if contacted, but at the present time neither
he nor CU has any plans to contact these people and does not

them. KAISER said that VILEREDO NAVARRO is a long-time

KISSINGER'S VISIT IN VENEZUELA WHICH HOULD TEND TO DISCREDIT HIM

AND THE PRESIDENT OF VENEZUELA.

AS A RESULT OF THESE REPORTED DISCUSSIONS, THE SOURCE HAD BEEN LED TO BELIEVE THAT POSSIBLY THESE PLANS MIGHT RESULT UN AN ASSASSINATION ATTEMPT ON KISSINGER WHEN HE WAS VISITING IN VENEZUELA.

STURGIS EXPLAINED THAT THIS SOURCE WAS UNTBLE TO FURNISH ANY OTHER DETAILS IN CONNECTION WITH THIS INFORMATION AND NO OTHER MEMBERS OF THE GROUP WERE IDENTIFIED. STURGIS UNDER STOOD THAT THE SOURCE HAD OBTAINED THE INFORMATION ABOUT THE ALLEGED PLANS FOR CREATING AN INTERNATIONAL INCIDENT IN-VOLVING KISSINGER THIRDHAND. THE WIFE OF A MAN AHO WAS CONNECTED WITH A MEMBER OF THIS GROUP HAD OVERHEARD HEA HUS BAND TALKING ON THE TELEPHONE ABOUT KISSINGER'S VISIT TO VENEZUELA AND HAD REPORTED THIS INFORMATION TO THE SOURCE.

STURGIS ADVISED THAT NOW THAT KISSINGER'S VISIT TO VENEZUELA HAD BEEN CANCELLED, HE UNDERSTOOD THAT ALL PLANS "HAD BEEN ABORTED" AND THAT THERE WAS NO IMMEDIATE DANGER OR ALTHOUGH NO DEFINITIVE PLANS OF THE GROUP WERE KNOWN. STURGIS UNDERSTOOD THAT THE GROUP HAD ONLY DISCUSSED POSSIBLE PLANS FOR AN INCIDENT INVOLVING BOTH KISSINGES AND THE PRESIDENT OF VENEZUELA DURING SUCH A VISIT IN ORDER TO DISCREDIT UNITED STATES-VENEZUELA PELATIONS.

STURGIS POINTED OUT THAT THE CUBAN EXILES ARE ALWAYS TALKING, CONSPIRING AND PLANNING SOME SORT OF AUTI-CASTRO ACTIONS, BUT IT IS PRIMARILY IDLE AND HOPEFUL GOSSIP AND RUMORS THAT COME TO NOT HING

STURGIS STATED THAT ALTHOUGH HE FELT THERE WAS NO IMMINENT DANGER IN THESE ALLEGED THREATS, HE HAD PROMPTLY REPORTED THIS INFORMATION TO AN ACCUAINTANCE OF HIS IN THE U.S. CUSTOMS AGENCY. MIAMI, FLORIDA. THIS U.S. CUSTOMS AGENT HED ADVISED STURGIS THAT HE WOULD PROMPTLY REPORT THIS INFORMATION TO THE U.S. SECRET SERVICE: MIAMI, WHICH AGENCY HAD PROTECTIVE JURISDICTION FOR U.S. CABINET MEMBERS, ACCORDINGLY, STURGIS UNDERSTOOD THAT THIS MATTER WAS BEING APPROPRIATELY HANDLED BY THE U.S. GOVERNMENT.

No specific date for the meeting was given to WH, but it is assumed that the meeting will take place within the next few-days.
