## Mr. Bruce C. Mastrocola

Dear Mr. Mastrocolar

The United States Covernment, as represented by the Contracting Officer, hereby contracts with you as an independent contractor for the submission of certain information and related services of a confidential nature under the following terms and conditions:

1. Compensation. In full consideration for the submission of such information and services you will be paid a fee of \$50 for any day or fraction thereof during which you are utilized under this agreement, not to exceed \$265 per weak. Fayments will be made as directed by you in writing in a manner acceptable to the Government. No taxes will be withheld therefrom, but it will be your responsibility to report such income under existing Federal income tax laws and regulations. An appropriate Form 1079 will be furnished by the Government-in furtherance of its tax reporting requirement.

2. Travel. You will be advanced or reinbursed funds for necessary empiness incurred in connection with such operational travel as may be directed or authorized by the Government. This may include per diem in lieu of subsistence in the course of such travel and while on temport : duty \* Ay from your domestic permanent post of assignment. Payment and accounting for such expenses will be in substantial conformance with applicable Government regulations.

3. Operational Expanses. You will be advanced or reinbursed funde for necessary operational capsusses including, but not limited to, substainmont and the purchase of information, as specifically approved by the Coversment. Such funde will be subject to accounting in substantial compliance with Coverament regulations.

4. Execution of Decimients. If, in the performance of corrient under this contract, you genume the custody of Government funds or take title of record to property of any nature whatecover and wherever vituate, which property has in fact been purchased with menter of the U.S. Government, you hereby recognize and acknowledge the existence of a trust relationship, either express or constructive, and you agree to execute whatever documents may be required by the Government to evidence this relationship.

5. Status. You are not an employee of the United States Coverns ont under this agreement and are not empirical to any benefits normally incluent to an employee status.

5. Socrecy. You will be required to keep forever secret this contract and all information which you may obtain by reason hereof (unless released in writing by the Government from such obligation), with full knowledge that visinities of such secrecy may subject you to criminal presecution under the Esplonage Laws, dated 25 June 1948, as amended, and other applicable laws and regulations.

9. Instructions. Instructions received by you from the Government in briefing or otherwise are a part of this contract and are incorporated herein. provided that such instructions are not inconsistent with the forms hereof.

8. Unautherized Commitments. No promises or commitments pertaining to rights, privileges or bonstite other than these expressly elipulated in writing in this agrooment or any amendment thereis shall be binding on the Government.

. 9. Torm. This contract is effective as of 5 June 1959, and shall continue thereafter for a period of one (1) year unless sooner terminated others

(a) By thirty (30) days' actual notice by either party hereto, or

(b) Without prior notice by the Covernment, in the event of a breach of this contract by your violation of the security provisions hereof or by your otherwise sendering yourself unavailable for acceptable service.

Subject to the availability of appropriations, this agreement may be extended upon notice from the Government. Termination of this agreement will not release you from the obligations of any security eath you may be required to tako.
