Asked questions re ODACID contact with AMBUD in WAVS area and whether ODACID would handle 6-AMIRON. Para 2 said WAVS preferred, for security reasons, not discuss with 6-AMIRON matter of transferring AMIRON personnel from San Pedro Sula to Tegucigalpa as requested by Station TEGU.
