E. Statement by Coordinator General of 30 November Movement.

WAVE reaction to questions raised in memos is as follows: 2.

A. There is no reason for us to subsidize the "Diario Las Americas" in order to furnish the ALSUD gratis publicity in the local colony.

B. Daily personal expenses on tours should be kept down to approximately \$15 a day as there has been much criticism of lavish living on these tours in Latin America.

C. We shall suggest to AMEUD-1 that a pilot radio program once or twice a week be started over WaL in New Orleans to determine its effect in Cuba and Latin America.

D. We shall keep ANBUD-1 informed of all future tours undertaken by affiliates, but no detailed expose of past operations will be given. 1 -160
