IF QUERIED BY PRESS,

1. SUGGEST QUMALT BE THOROUGHLY ADVISED OF THE NEED TO MAKE THAT CLEAN, FIRM DENIAL CHARGES OF CUBAN GOVT/QUMALT DIRECTLY INVOLVED AMLASH/1 AND ANTRUNK/10 CASE.

2. QUMALT LINE SHOULD BE ACCUSATION: IS TIME-WORN CASTRO TECHNIQUE MAKE UNFOUNDED CHARGES AGAINST THOSE WHO HAVE BROKEN WITH HIS REGIME AND THEREBY DIVERT PUBLIC ATTENTION FROM MOUNTING INTERNAL DIFFICULTIES.

3. QUMALT SHOULD AVOID ANY MENTION KUBARK. IF ASKED HE SHOULD TRY TO SIDESTEP QUERY BY DENYING KNOWLEDGE OF CASE. ONLY IF PRESSED ON KUBARK RELATIONSHIP HE SHOULD MAKE FIRM DENIAL HE HAS HAD ANY CONNECTION.

4. QUMALT TO CLAIM IT GROSS FABRICATION THAT HE REQUESTED AND ACCEPTED \$100,000 FOR HIS COLLABORATION IN AMLASH/1 CASE.

5. QUMALT MAY STATE HE KNEW "GALLARRETA" AND OTHERS (WHO INDEED KNOWN TO QUMALT) MENTIONED IN PRENSA LATINA RELEASE OF 5 MARCH BUT TO EMPHATICALLY STATE HE NOT INVOLVED. QUMALT TO MAKE STATEMENT CASTRO CHARGES ARE SIMPLY DEVICE DEFAKE HIS OPPONENTS AND CASTRO IS SIMPLY IMPLYING THAT THERE IS NO HONEST AND FUNDAMENTAL
