HOWEVER, IT APPEARS THAT USG POSITION WILL BE THAT THRUST OF SUMMIT MEETING WILL BE ON DISCUSSING MEANS OF IMPLEMENTING AND STRENGTHENING THE ALLIANCE FOR PROGRESS. CONTROVERSIAL ITEMS SUCH AS CUBA ARE NOT DESIRED AS PART OF THE FORMAL AGENDA, BUT WILL UNDOUBTEDLY BE THE SUBJECT OF DISCUSSION AT INFORMAL MEETINGS. UNDER THESE CIRCUMSTANCES ANCORE-2'S EFFORTS TO PLACE CUBA ON THE AGENDA (WHICH WOULD BE INADMISSIBLE AT LEAST TO MEXICO) ARE COUNTERPRODUCTIVE FROM THE U.S. POINT OF VIEW.</p> <p>2.
