- 2. IF HIDALGO HAS NO PERSONAL KNOWLEDGE OF LAMONT'S COMMUNIST PARTY MEMBERSHIP, THE FBI HAS REQUESTED THAT HE BE ASKED FOR THE NAMES OF ANY INDIVIDUALS WHO HE MIGHT THINK WOULD BE IN A POSITION TO FURNISH INFORMATION OF THIS NATURE.
- 3. THE FET HAS REQUESTED THAT THIS INQUIRY OF THEIR'S BE KEPT CONFIDENTIAL.
