The Subject is a covert employee of this Agency now in the United States for four weeks training and being considered for use by Staff C/ICB in a highly sensitive assignment. Immigration authorities may submit questions through this Agency which will be answered by the Subject, but requests to have the Subject testify in open court hearings must be refused.

DETAILS

1. Reference is made to the letter received by the Alien Affairs Staff from the Immigration and Naturalization Service and reference to your request of 15 June 1954 to ascertain the details of the Subject's status with this Agency and prepare a reply to I&NS.

2. On 17 June 1955 Special Agent Chester R. HOATSON of this office interviewed Mr. Robert DAHLGREN, Acting Chief, MH/FI, Room 1128 "J" Building, and MR (John BONNIT) Chief, WH/Panama, Room 2201 Suarters "J", xh156, regarding the Immigration request. The following information was obtained during this interview.

a. The Subject is still a covert employee of this Agency, is now in the United States (New York City) on home leave, and is scheduled to report to Washington, D.C., to commence four weeks of covert trainingon 6 July 1954.

b. The Subject is presently under consideration by Staff C/JCB for an assignment with a highly sensitive project under the supervision of Staff C/JCB. Under this proposed assignment any publicity or notoriety that the Subject would receive from testifying publicly on questions of Communist associations of which he may have knowledge would ultimately preclude his future use with the Staff C project and would probably jeopardize his future as a covert employee of this Agency.

3. Mr. D.HH GREN and Mr. EGUILT indicated that from a WH standpoirt only there would be no objection to a controlled interview with the Subject if the interview hould be afforded the Subject while he is still in New York City. This, however, would have to be coordinated with Staff O/HCH for possible objections that they might raise in view of their proposed use of the Subject. Mr. BOTHET represents that he le informed of any action taker in this matter and any public testimony or oper court testimory would have to depend on the seriousness of the case teing prepared by the Immigration authorities. 「「「「「「「「」」」

h. Any contact with the Subject during his period of covert training from 6 July to approximately 15 August 195h would have to also be corndinated with Dr. Covert Training Officer, OTE, whose office is located in Building, T-31.

FURNE) Staff T/JOB, 1613 "I" Building, x668, to discuss the Subject's future position and also the recuest received from JENS. The following factors were obtained from Mr.(BURNE)

a. The Subject's use in the proposed Staff C project is still in the planning stage, but the assignment that the Subject is being considered for is a highly sensitive one and any further publicity which the Subject may receive would ultimately discualify him for consideration on this project.

b. Any approval for IMNS contact of the Subject would have to be determined after carefully considering the importance of the IMNS case for which the Subject's testimony may be required. If (BURKE) indicated that the Subject could still be considered as an employee of NH Division regardless of whether or not the proposed Staff C/TCB assignment materializes and any action in the request received from IENS should be closely coordinated with both Staff C and WH.

6. Mr. PENNINGPON, Alien Affairs Staff, SO, contacted William A. HOGAN, Special Assistant to the Commissioner of Immigration and Naturalization on 18 June 1954 requesting further information regarding their memorandum of 9 June 1954 on the Subject. Mr. HOGAN explained that IENS has a list of possible informants which contains the Subject's name. The people on this list are being contacted for use on a continuing basis when specific cases arise which might fall in their particular area of knowledge. At the present time, JENS has no specific case forwhich they want to contact the Subject, but they just want to know if he would be available in the future for use as an informert regarding various Communist activities of which the Subject has personal knowledge.

7. After his conversation with Mr. HOB'N, Mr. FEMMINGTON indicated that a refusal of the IMS request would not be considered out of order, but recommended cooperating to the entent that I MF could submit specific questions to this Agency which could be presented to the Subject and the answer forwarded to 1 MS. The refusal of their original request should be based on the sensitivity of the Subject's position which could be jeopardiced by any undue publicity and also on the fact that the Subfact a was frequently and it would be difficult to locate him well as proposed was printing.

I. I. James SPECUSE, Then Affrice Staff/SC, stated on 18 Sume 1951 that Mr. HOGAN, Special Issistant to the Commissioner of Innigration and Naturalization, had indicated in a conversation with in. SPECUEL on 8 June 1954 that ISMS had been able to locate the Subject's location and affiliation with this Agency through the Subject's father who told the inspector that the Subject was subject by this Agency in _______ which appears to be a security flap on the part of the Subject's father.

1. In (John BCHTET) Chief, MH/Panama, was recontacted on 18 Cure 1451 and informed of the nature of the 1 ME request and also informed of the apparent scourity flap on the part of the Subject's father. Son the basis of this further information, it was suggested to Mr. (BONTET) that the JANS authorities be requested to submit any cuestions through this 'gency which would, in turn, be presented to the Subject and his answers be returned to JANS. Mr. (BONTET) agreed to the proposal of having the JANS people contact the Subject of through this Agency and also indicated that the reported security breach on the part of the Subject's father would be taken into consideration and an attempt would be made to determine the extent of the Subject's relatives or acquaintances know of the Subject's employment by this Agency. Mr. (Paul FURKE) Staff C/JCB, also agreed to the proposed procedure and requested that any and all action taken be coordinated with WH and Staff C.

ACTION

It is recommended that the attached memorandum to I&NS and to the Chief, NH Division, with a carbon copy to Staff C/ICE, be forwarded and that no further action betaken pending a report from Mr. OS (BINEE) regarding the seriousness of the security flap from an opertional standpoint.
