- 8. Gerald Patrick HEMMING is well known to this Agency, the Office of Security Miami Field Office, and JNWAVE. On numerous occasions since at least the early 1960's, HEMMING had claimed Agency affiliation when in fact there has been none. The most recent incident wherein HEMMING claimed such affiliation was in May 1975 when he volunteered his services to the Drug Enforcement Administration. Gerald Patrick HEMMING is a long-time cohort of Frank Anthony STURGIS (SF#353 459), aka: Frank FIORINI, of Watergate notoriety who also has a long-time record of falsely claiming Agency affiliation. In the late 1950's HEMMING and STURGIS, both former U.S. Marines, joined Fidel CASTRO in Cuba but returned shortly thereafter claiming disillusionment with the CASTRO cause. Soon thereafter, STURGIS organized a group of mercenaries for Caribbean and Central American activities which he named the International Anti-Communist Brigade. A reported sub-unit of this "Brigade" (the backers of whom have never been fully established) was named the Intercontinental Penetration Force, headed by Gerald Patrick HEMMING.
