MEMORANDUM FOR THE DIRECTOR

1. TELEPHONE RECEIVED COPY OF LETTER FROM [REDACTED] TO APRIL COFFO OFFERING HIM JOB AS ORGANIZER IN 1964 AND AUTHORIZING HIS CODE NAME FOR ORGANIZERS CONFERENCE. TELEPHONE POINTED OUT COFFO'S UNLAWFUL REFUSION AND SUGGESTED CHECK WITH [REDACTED].

2. COFFO SAYS HE WOULD NOT HIRE COFFO UNDER ANY CIRCUMSTANCES. HE CONSIDERS COFFO A CROOK, ONLY INTERESTED IN MONEY AND UNDOUBTEDLY WOULD BRING IN POLITICAL VIEW OF THEODORE HAZELL. COFFO SAYS COFFO WAS CHIEF FINANCIAL OFFICER OF [REDACTED] OF [REDACTED], NOT IN [REDACTED] THIS COMPANY A TECHNICALITY AND HE OWES \$125,000. TELEPHONE SAYS HE WILL BE ANOTHER REFUGEE. THIS OFFER MADE WITHOUT COFFO'S KNOWLEDGE.

3. COFFO EMPHATICALLY HAS GROWN TIER WITH CIA AND PARTICULARLY EAR HENRY. HIS BELIEVES [REDACTED] AND [REDACTED] COULD BE [REDACTED] APPROVAL OF ONLY SIX MONTHS [REDACTED]. [REDACTED] BELIEVE HE SHOULD GIVE [REDACTED] TO OFFICE OF U.S. AMBASSADOR. [REDACTED] SPECIAL FUNDS WILL BE AVAILABLE FOR ANY PROGRAM HANDLED BY COFFO.
