

9 OCTOBER 1959: ACCORDING TO OFFICIAL BRITISH TRAVEL RECORDS OSWALD ARRIVED IN SOUTHAMPTON THIS DATE CLAIMING ON HIS LANDING CARD THAT HE HAD HO FIXED ADDRESS BUT PLANNED TO REMAIN IN THE UNITED KINGDOM ONE WEEK FOR VACETION BEFORE GOING ON TO "SOME SCHOOL IN SWIESE." (HEADQUARTERS COMMENT: PROBABLY REFERRING TO THE ALBERT SCHWEITZER COLLEGE IN SWITZERLANDSWIETHINH MENTER IS KNOWN CONDUCTED ON 24 MAY 197 TO HAVE BEEN IN CORRESPONDENCE.) IMPDET CL BY\_

в. 10 OCTOBER 1959: ACCORDING TO THE SAME OFFICIAL BRITTSH TRAVEL 1976 RECORDS OSWALD LEFT LONDON THIS DATE BY AIR FOR HELSINKI.

APR OCTOBER 1959: STOCKHOLEM HEWSPAPER "DAGENES NYHETER" OF 25 NOVEMBER C. 51963 STATES LEE OSWALD PASSED THROUGH SWEDEN DURING OCTOBER 1959. ARTICLE ALSO ADDS THAT OSWALD WAS UNSUCCESSFUL IN OBTAINING VISA TO THE USSR IN HELSEINKI WHICH RESULTED IN HIS RETURNING TO STOCKHOLM. TWO DAYS AFTER HE ARRIVED IN STOCKHOLM OSWALD TRAVELED DIRECTLY TO MOSCOW. CONCLUDING SENTENCE OF ARTICLE STATES "THIS DINDICATES THAT THE RUSSIAN EMBASSY (STOCKHOLM) GAVE HIM A VISA." ACCORDING TO A RELIABLE SOURCE THERE WAS NO RECORD THAT THERE WAS ANY REQUEST FOR A USSR VISA PROCESSED THROUGH NORMAL CHANNELS FOR OSWALD AT ANY TIME DURING 1959, AND 201-289248 Vilio-5-41 COORDINATING OFFICERS GROUP 1 Excluded from au ELEASING OFFICER AUTHENTICATING OFFICER SECRET declassification

INFO CITE DIR SOURCE INDICATED IT WAS DIFFICULT TO EXPLAIN HOW OSWALD MIGHT HAVE RECEIVED HIS VISA IN TWO DAYS WITHOUT GOING THROUGH NORMAL CHANNELS. THE ONLY CONCLUSION WHICH CAN BE DRAWN IS THAT OSWALD MUST HAVE RECEIVED HIS VISA DIRECTLY FROM THE SOWIET IMBASSY IN STOCKHOLM WHICH OCCASIONALLY IS DONE IN SPECIAL CASES, BUT THE SOURCE HAD NO EVIDENCE TO CONFIRM THIS ASSUMPTION.

10 TO 15 OCTOBER 1959: ACCORDING TO A VERY RELIABLE BUT EXTREMELY D. SERSITIVE SOURCE OSWALD STAYED AT THE TORNI HOTEL IN HELSINKI FROM 10 TO 11 OCTOBER AND THEN MOVED TO THE KLAUS KURKI HOTEL WHERE HE STAYED UNTIL 15 OCTOBER, APPARENTLY WAITING FOR A VISA TO BE ISSUED HIM BY THE SOVIET CONSULATE IN HELSINKI. HE TRAVELED TO THE USSR BY TRAIN, CROSSING AT VAINIKKALA ON 15 OCTOBER.

13 MAY 1962: ACCORDING TO A DUTCH OFFICIAL SOURCE, THE DUTCH E. CHARCE IN MOSCOW ISSUED A TRANSIT VISA TO OSWALD'S WIFE ON 13 MAY 1962. THERER . RECORDS REVEAL HIS WIFE WAS BORN ON 17 JULY 1941 INSTRAD OF 19 JULY 1941 AND IN SEVERODVINSK INSTEAD OF MINSK. THERE IS NO RECORD OF HER HAVING ACTUALLY TRANSITED THE NETHERLANDS.

F. 1962: OFFICIAL BRITISH RECORDS DO NOT REFLECT THAT OSWALD RETURNED. TO THE UNITED STATES FROM THE USSR THROUGH THE UNITED KINGDOM. HOWEVER, IF HE WERE MERELY TRANSITING, IT WOULD NOT HAVE BEEN NECESSARY FOR HIM TO FILL OUT A LANDING CARD, AND THEREFORE THERE WOULD BE NO RECORD OF HIS TRAVEL IN THE

G. 1963: ACCORDING TO AN EXTREMELY SENSITIVE AND RELIABLE SOURCE, CH 23 NOVEMBER MARIA EMETHIACE, HEAD OF THE "WEXKGROUP INFORMATIE CUBA," TOLD AN INFLOMES OF THE CUBAN EMEASSY IN THE HAGUE THAT SHE WAS SURE SHE HAD MET "THAT NR. LEE IN HAVANA, WHO DID THE MORDER." SHE DESCRIBED HIM AS A MAN OF VIOLENCE AND EMPIRELY FULL OF HATE AND INDICATED THAT IT WAS POSSIBLE THAT THE MAN HAD DEEM MISUSED BY A GROUP. SHE SAID SHE HAD WRITTEN TO "GIBSON" ABOUT THE BAD INFRASSION SHE HAD HAD OF THIS LEZ. (HEADQUARTERS COMMENTS: FLEASE REFER TO OUR TELSTYPEN NOS 85182 AND 85665 FOR ADDITIONAL INFORMATION ON GIBSON.)
