 REGARDING THE TRAVEL OF LIKE HARVEY OSWALD AND HIS WIFE:
- A. 9 OCTOBER 1959: ACCORDING TO OFFICIAL BRITISH TRAVEL RECORDS

 OSWALD ARRIVED IN SOUTHAMPTON THIS DATE CLAIMING ON HIS LANDING CARD THAT HE HAD

 HO FIXED ADDRESS BUT PLANNED TO REMAIN IN THE UNITED KINGDOM ONE WEEK FOR VACATION

 BEFORE GOING ON TO "SOME SCHOOL IN SWIESE." (HEADQUARTERS COMMENT: PROBABLY

 REFERRING TO THE ALBERT SCHWEITZER COLLEGE IN SWITZERLANDSWIESE, WHILE, HE IS KNOWN

 TO HAVE BEEN IN CORRESPONDENCE.)
- B. 10 OCTOBER 1959: ACCORDING TO THE SAME OFFICIAL BRITTSH TRAVEL RECORDS OSWALD LEFT LONDON THIS DATE BY AIR FOR HELSINKI.
- C. OCTOBER 1959: STOCKHOLEM NEWSPAPER "DAGENS NYHETER" OF 25 NOVEMBER 51963 STATES LEE CSWALD PASSED THROUGH SWEDEN DURING OCTOBER 1959. ARTICLE ALSO ADDS THAT CSWALD WAS UNSUCCESSFUL IN OBTAINING VISA TO THE USSR IN HELSKINKI WHICH RESULITED IN HIS RETURNING TO STOCKHOLM. TWO DAYS AFTER HE ARRIVED IN STOCKHOLM CONCLUDING SENTENCE OF ARTICLE STATES "THIS INDICATES THAT THE RUSSIAN EMBASSY (STOCKHOLM) GAVE HIM A VISA." ACCORDING TO A RELIABLE SOURCE THERE WAS NO RECORD THAT THERE WAS ANY REQUEST FOR A USSR VISA PROCESSED THROUGH NORMAL CHANNELS FOR OSWALD AT ANY TIME DURING 1959, AND

SOURCE INDICATED IT WAS DIFFICULT TO EXPLAIN HOW OSWALD MIGHT HAVE RECEIVED HIS VISA IN TWO DAYS WITHOUT GOING THROUGH NORMAL CHANNELS. THE ONLY CONCLUSION WHICH CAN BE DRAWN IS THAT OSWALD MUST HAVE RECEIVED HIS VISA DIRECTLY FROM THE SOVIET EMBASSY IN STOCKHOLM WHICH OCCASIONALLY IS DONE IN SPECIAL CASES, BUT THE SCURCE HAD NO EVIDENCE TO CONFIRM THIS ASSUMPTION.

- 10 TO 15 OCTOBER 1959: ACCORDING TO A VERY RELIABLE BUT EXTREMELY SEESTIVE SOURCE CSWALD STAYED AT THE TORNI HOTEL IN HELSINKI FROM 10 TO 11 OCTOBER AND THEN MOVED TO THE KLAUS KURKI HOTEL WHERE HE STAYED UNTIL 15 OCTOBER. APPARENTLY WAITING FOR A VISA TO BE ISSUED HIM BY THE SOVIET CONSULATE IN HELSINKI. HE TRAVELED TO THE USER BY TRAIN, CROSSING AT VAINIKKALA ON 15 OCTOBER.
- E. 13 MAY 1962: ACCORDING TO A DUTCH OFFICIAL SOURCE, THE DUTCH CHARGE IN MOSCOW ISSUED A TRANSIT VISA TO OSWALD'S WIFE ON 13 MAY 1962. THERIR RECORDS REVEAL HIS WIFE WAS BORN ON 17 JULY 1941 INSTRAD OF 19 JULY 1941 AND IN SEVERODVINSK INSTEAD OF MINSK. THERE IS NO RECORD OF HER HAVING ACTUALLY TRANSPIED THE NETHERLANDS.
- F. 1962: OFFICIAL ERITISH RECORDS DO NOT REFLECT THAT OSWALD RETURNED TO THE UNITED STATES FROM THE USER THROUGH THE UNITED KINGDOM. HOWEVER, IF HE WERE MERELY TRANSITING, IT WOULD NOT HAVE BEEN NECESSARY FOR HIM TO FILL OUT A LANDING CARD, AND THEREFORE THERE WOULD BE NO RECORD OF HIS TRAVEL IN THE

- 1963: ACCORDING TO AN EXTREMELY SENSITIVE AND RELIABLE SOURCE, OH 23 NOVEMBER MARIA BNETHLAGE, HEAD OF THE "WERKGROUP INFORMATIE CUBA," TOLD AN EMPLOYER OF THE CUBAR EMBASSY IN THE HAGUE THAT SHE WAS SURE SHE HAD MET "THAT Her. Left in havana, who did the morder." She described him as a man of violence AND ENTIRELY FULL OF HATE AND INDICATED THAT IT WAS POSSIBLE THAT THIS MAN HAD BYTTE MISUSED BY A CROUP. SHE SAID SHE HAD WRITTEN TO "GIBSON" ABOUT THE BAD IMPRESSION SHE HAD HAD OF THIS LEE. (HEADQUARTERS COMMENTS: PLEASE REFER TO OUR TELETYPES NOS 85182 AND 85665 FOR ADDITIONAL INFORMATION ON GIBSON.)
