WE DID NOT DISCUSS INFO CONTAINED REF A WITH CONSULATE FOR TWO REASONS: INFO RECEIVED FROM(SYMPATHIZERS)<sup>01</sup> WELL AFTER SUBJECT'S INTENDED DEPARTURE DATE, AND IF SUBJECT NEEDED VISIT CONSULATE FOR VISA HE ALREADY WOULD HAVE DONE SO. SECOND, DUE TO SENSITIVITY OF SOURCE OF INFO, WE PREFERRED NOT PROVIDE IT AFTER THE FACT TO ROTTERDAM CONSULATE, WHICH LACKS CLASSIFIED COMMO AND STORAGE FACILITIES.
