EMARTINEZ ASKED OUR SOURCE TO RELAY THE INFORMATION TO THIS AGENCY.

- A. MARTINEZ WAS CONTACTED IN MIAMI, FLORIDA BY SALVADOR ALDEREGUIA, AKA "EL GALLEGO" AND ASKED TO MEET WITH A CUBAN INTELLIGENCE OFFICER IN MONTEGO BAY, JAMAICA ON 24 MAY. ALDEREGUIA TOLD MARTINEZ THAT IN VIEW OF MARTINEZ' IMPRISONMENT AND MISTREATMENT BY THE U.S. GOVERNMENT (USG) FOLLOWING THE WATERGATE AFFAIR, THAT MARTINEZ MIGHT BE INTERESTED IN MEETING WITH THE CUBAN IS OFFICER.
