1. DESPITE **STATION** PRESSURE TIPSTAFFS HAVE HELD BACK ON REF INTERROGATION. AFTER SERIES EXCUSES TIPSTAFF/4 FINALLY ADMITTED 20 AUGUST THAT THEY FEAR PUBLICATION IN PBPRIME OF FULL REPORT INCLUDING ANY RESULTS THEIR INVESTIGATION, THUS REVEALING **KUBARK/TIP-STAFF** COLLABORATION. WE REPLIED CASE IS PURELY POLICE MATTER IN WHICH EVEN SOVIETS COOPERATED TO SOME DEGREE. T/4 AGREED BUT SAID THAT INVESTIGATION SHOULD THEN BE MATTER OFFICIAL REQUEST FROM EMBASSY TO FOREIGN OFFICE.

2. ODENVY REP, WHO JUST LEAVING **STOC** WHEN ABOVE REVEALED, VOLUNTEERED MAKE APPROACH TO REGULAR POLICE ON CASE DURING HIS NEXT VISIT CA 1 OCTOBER.

3. WE BELIEVE LATTER COURSE STANDS BETTER CHANCE SUCCESS AND IS MORE SECURE THAN FORMER IF TIME DELAY ACCEPTABLE.
