1. SUBJ REF MET BY GESTETNER 16 DEC. APPEARS HE ANTI-SOV BASIS RELIGIOUS CONVICTIONS, IS WILLING WORK WIT. JOYNE AGAINST SOVS. REMUNERATION NOT DISCUSSED BUT SALARY WOULD BE MINIMAL.
2. FROM INITIAL DEBRIEFING, APPEARS ABOUT ONE QUARTER OF SOVENS COMPLEMENT FREQUENT STORE FROM TIME TO TIME GETTING SNACK AND DRINKING TEQUILLA, ABOUT ONCE OR TWICE WEEKLY TWO OR THREE SOVS ENTER STORE AFTER CLOSING TIME AND DRINK FOR HOUR OR MORE. HE ON FRIENDLY BASIS BUT BY NO MEANS INTIMATE WITH SOVS WHO UNDERSTAND HE DOES NOT CARE THEIR POLITICAL CONVICTIONS.
