SUCH INQUIRIES COULD LEAD TO THE COMPROMISE OF OUR SOURCE. FOR THIS REASON, THEREFORE, THE PHOTOGRAPHS CANNOT BE RELEASED AS REQUESTED IN YOUR MEMORANDUM 40 OF MAY ONE FIVE ONE NINE SEVEN TWO. UNQUOTE. CROPPED PHOTOS IN POSSESSION OF LEGAT, MEXICO, NOT BEING SUBMITTED IN ABSENCE OF FURTHER INSTRUCTIONS FROM BUREAU. Classified Exempt from GDS.
