[CARL N. MARTIN, JR., Chief, Philadelphia Office, Central Intelligence Agency (CIA) Domestic Contact Service] was contacted on 10/14/65 as directed in referenced SAC Letter.

[Mr. MARTIN] advised he had just returned from conferences at his Agency Headquarters in Washington, where he had been advised the Bureau was directing its field offices to establish liaison with the local offices of the [Domestic Contact Service]. Mr. [MARTIN] offered his complete cooperation with this office in matters of mutual interest.

Arrangements were perfected wherein Agents of this office making inquiries or investigations of a Soviet-Bloc National can contact [Mr. MARTIN] and he will place them in contact with the [Domestic Contact Service] representative handling the case, so that information of interest to us can be secured. Any information coming to the attention of the [Domestic Contact Service] relating to our internal security responsibilities will be immediately reported to this office.

Mr. MARTIN requested, in view of his Agency's regulations, that CIA not be identified as the source in the event

information received from his office should be included in a communication going to anyone outside the Bureau. Mr. MARTIN was assured that CIA's identity in this regard would be fully protected.

Mr. MARTIN pointed out that the territory covered by his office included the State of Delaware and the southern half of New Jersey, running from and including Princeton, N.J., and Atlantic City, N.J. He also pointed out that his office did not cover State College, Pa., as this is covered by the Domestic Contact Service Office at Pittsburgh, Pa. He suggested the same procedure be followed for cases in Delaware and Southern New Jersey, as is contemplated for the Philadelphia Office territory. That is, that this office contact him, furnishing the identity of the Subject and the name and location of the Special Agent handling the case. He then will have his representative covering the area contact the FBI Agent and they then can discuss information of mutual interest on the case. He advised that SAMUEL C. REED, JR., covers the Princeton area, where the bulk of these cases are located in Southern New Jersey and BARBARA COOKE covers the State of Delaware.

REQUEST OF THE BUREAU:

In the course of future contacts with CIA in these cases, it is anticipated that CIA representatives may at times request information relating to Subjects' background, habits, and characteristics, as well as any available photographs.

The Bureau is requested to advise if it will be permissible to orally furnish such background information to the CIA representative and to furnish copies of photographs, if they are available.

The Bureau is also requested to advise if the establishment of liaison on the field office level with [CIA's Domestic] [Contact Service] envisages the furnishing of reports and letterhead memos to this Service at the field office level where they have a legitimate interest in the Subject. JFK(1)(3)
