COUNTRIES, ACCORDING TO A HIGH-RANKING OFFICIAL OF  
THE GOVERNING VENEZUELAN SOCIAL CHRISTIAN (COPEI) Ven.  
PARTY WHO ALSO IS INTIMATELY INVOLVED IN THE CURRENT  
NEGOTIATIONS FOR ESTABLISHMENT OF SUCH RELATIONS.  
THIS OFFICIAL SAID IN EARLY JULY 1973 THAT NEGOTIATIONS  
BETWEEN THE TWO COUNTRIES NOW HAVE ADVANCED TO THE  
STAGE WHERE IT IS APPROPRIATE AND NECESSARY THAT THEY  
BE CONDUCTED AT THE CHIEF OF GOVERNMENT LEVEL.  
ACCORDINGLY, VENEZUELAN PRESIDENT RAFAEL CALDERA  
WILL STOP BRIEFLY IN CUBA ON HIS WAY BACK FROM ATTEND-  
ING THE UNITED NATIONS GENERAL ASSEMBLY MEETING IN  
NEW YORK IN SEPTEMBER TO PERSONALLY DISCUSS VENEZUELAN/  
CUBAN RELATIONS WITH CUBAN PRIME MINISTER FIDEL  
CASTRO RUZ. (TDFIRDB-315/06639-73)

IT BY A THIRD COUNTRY. (SOURCE COMMENT: THE OFFICIAL DID NOT IDENTIFY THE THIRD COUNTRY.) (FIELD COMMENT: [HVC-6711]<sup>(S)</sup> TDFIR-314/ 04600 -73, IS THE MOST RECENT REPORT ON SOVIET NEGOTIATIONS WITH VENEZUELA FOR PURCHASE OF PETROLEUM FOR SHIPMENT TO CUBA. BASED ON THIS AND PREVIOUS REPORTS, THE THIRD COUNTRY REFERRED TO BY THE COPEI OFFICIAL IS PROBABLY THE USSR.) ALTHOUGH CUBA HAS LITTLE THAT COULD ADEQUATELY COMPENSATE VENEZUELA FOR OIL, THE ESTABLISHMENT OF COMMERCIAL RELATIONS BETWEEN THE TWO COUNTRIES IS PLANNED PRIOR TO THE ESTABLISHMENT OF DIPLOMATIC RELATIONS.

3. (FIELD COMMENT: A SOURCE WHO IS BELIEVED TO PROVIDE ACCURATE INFORMATION REPORTED IN EARLY JULY THAT HE HAD BEEN TOLD BY ~~LUIS~~ O V A R, HEAD OF THE SENATE COMMISSION ON MINES AND HYDROCARBONS, THAT ONE OF PRESIDENT CALDERA'S OBJECTIVES IN MAKING THE TECHNICAL STOP IN CUBA IS TO DISCUSS THE SALE OF VENEZUELAN PETROLEUM TO CUBA. HE SAID DISCUSSIONS ON THE SALE HAVE BEEN HELD ALREADY BUT THE VENEZUELAN GOVERNMENT HAS DECIDED TO POSTPONE ANY ACTION ON THE

NEGOTIATIONS UNTIL THE CALDERA STOP IN CUBA TAKES PLACE. THE VENEZUELAN GOVERNMENT EXPECTS THAT CASTRO WILL RAISE THE SUBJECT DURING HIS TALK WITH CALDERA AND THE LATTER PLANS TO RESPOND POSITIVELY TO THE CUBAN PROPOSITION FOR SUCH A SALE. TOVAR SAID COPEI HAS ARRANGED FOR THE MEETING BETWEEN THE TWO LEADERS WITH CAMPAIGN BENEFITS FOR THE DECEMBER PRESIDENTIAL ELECTION IN MIND. HE SAID GONZALO ~~X~~ A R C I A ~~X~~ BUSTILLOS, VENEZUELAN AMBASSADOR TO THE ORGANIZATION OF AMERICAN STATES, IS HANDLING THE ARRANGEMENTS ON THE PERTOLEUM SALE.)

4. ONE POINT WHICH HAS NOT YET BEEN RESOLVED IN CONNECTION WITH THE NEGOTIATIONS IS THE STATUS OF THE CHRISTIAN DEMOCRATS IN CUBA, AND THIS ALSO WILL BE DISCUSSED BY THE TWO LEADERS. IDEALLY, VENEZUELA DESIRES THAT THE CUBAN GOVERNMENT LEGALIZE THE STATUS OF THE CHRISTIAN DEMOCRATIC MOVEMENT IN CUBA BUT VENEZUELA IS NOT SANGUINE ABOUT THE PROSPECTS FOR THIS. CALDERA THEREFORE IS PLANNING TO ASK CASTRO THAT HIS GOVERNMENT REMOVE THE RESTRICTIONS IT HAS PLACED ON THE MOVEMENT AND ON THE ACTIVITIES OF CERTAIN
