[BY CARACAS CIA STATION IN HVC] 7514 OF OCTOBER 13, 1976, REFLECTING (S)  
THAT BOSCH WAS QUOTED TO HAVE SAID AT FUND-RAISING DINNER IN  
CARACAS: "NOW THAT OUR ORGANIZATION HAS COME OUT OF THE LETELIER  
JOB LOOKING GOOD, WE ARE GOING TO TRY SOMETHING ELSE." ~~LEGAT~~  
[SOURCES] (S) HAD REPORTED THAT BOSCH CONTENDED IGNACIO NOVO SAMPOL AND  
GUILLERMO NOVO SAMPOL WERE RESPONSIBLE FOR THE OPERATION AGAINST  
LETELIER, AND THAT THEY UNDERTOOK THE ACTION FOR CHILEAN SECRET  
POLICE (DINA) ~~SECRET~~ (u)

IN VIEW OF SENSITIVE CIRCUMSTANCES, LEGAT'S [LIAISON CONTACTS  
WITH LOGICAL SOURCES IN] (S) POSITIONS TO PROVIDE ACCURATE INFORMATION  
IN LETELIER AND CUBANA CRASH MATTERS HAVE BEEN SOMEWHAT CURTAILED  
DURING THE PAST TWO WEEKS. EFFORTS WILL BE MADE AS SOON AS FELT  
ADVISABLE [TO RESUME REGULAR CONTACTS WITH THOSE SOURCES IN AN  
ATTEMPT] (S) TO DETERMINE WHAT, IF ANY, LINKS THE VENEZUELAN ANTI-CASTRO  
GROUP MAY HAVE TO THE LETELIER DEATH. (X) (u)
