THE CUBAN INTELLIGENCE SERVICE (CUIS) THROUGH THE CUBAN EMBASSY IN CARACAS. THE INFORMATION WAS PROVIDED IN THE FORM OF LETTERS, ACQUIRED FROM A CUBAN PENETRATION OF THE COORDINATED UNITED THESE LETTERS WERE REVOLUTIONARY ORGANIZATION (CORU). INTERCEPTED BY A CUIS SOURCE AND FORWARDED TO HAVANA FOR CLANDESTINE OPENING AND REVIEW. CUIS ANALYSTS COMPARED THE WHICH LETTERS REPORTEDLY ORIGINATED / JAILED CUBAN EXILE LEADER ORLANDON BOSCH WITH HANDWRITTEN PAPERS MANDES SIGNATURES AVAILABLE uba AT HAVANA UNIVERSITY. THE HANDWRITING OF THE INTERCEPTED LETTERS WAS CONFIRMED BY THE CUIS AS THAT OF BOSCH'S. THE TEXTS OF THE LETTERS WERE COPIED AND A COPY OF THE LETTERS AND A CUIS ANALYSIS OF THE CONTENTS WERE MADE AVAILABLE TO THE VENEZUELAN DIRECTORATE FOR THE SERVICES OF INTELLIGENCE AND PREVENTION (DISIP) AND TO VENEZUELAN PRESIDENT CARLOS ANDRES VPEREZ.
