HERNANDEZ REITERATED THE PERSONAL INTEREST OF FIDERIC A S T R O. PRESIDENT OF THE COUNCILS OF STATE AND MINISTERS. IN THE
DISPOSITION OF THE CASE AGAINST BOSCH. FURTHERMORE, HERNANDEZ
SAID THAT SHOULD THE VENEZUELAN SOVERNMENT DECIDE THAT THERE
IS INSUFFICIENT EVIDENCE AGAINST BOSCH IN CONNECTION WITH THE
