On 2/21/66, information was received from Central Intelligence Agency that its source, "Sugar," known to your office, had advised that on 1/26/66, while in Brussels, Belgium, he met a woman who called herself Lisa Armand. She advised "Sugar" that she was there for talks with Jacques Grippa, who is the leader of the pro-Chinese faction of the Belgian Communist Party, concerning the defense for William Epton. **Following** Sugar's conversation with Armand, he checked the hotel register where Armand was staying and determined that her passport identification listed her as Mrs. Frank. Subject has been active in pro-Chinese communist activities in the U. S. and reportedly is a contact of Chinese communist intelligence in London, England. Prior to her recent trip, subject made inquiry concerning the address of Richard Gibson, former head of Fair Play For Cuba Committee in the U. S. who was currently CIA source in London, England. Previous inquiry through CIA indicated subject was not known to 'Sugar' and he had no idea why subject would have his name and address in her possession. above additional information has now been received from CIA.
