On 6/20/62, WILLIAM MC CLAIR, Covert, CIA
representative, Miami, Florida, advised that he did not
think CIA had an operational interest in captioned
organization or Lignumvitae Key, which site is being
considered for use as a training camp by captioned
organization.

In view of instructions in referenced Departmental
letter to the Bureau, Miami will not actively investigate
captioned organization until CIA determines if that agency
plans to have an operational interest in captioned
organization.

is being furnished to U. S. Customs, Miami.
