For info of Bureau, CIA memo 3/18/66 containing reference to report that BOSCH said he purchased weapons from JUAN FERNANDEZ DE CASTRO it is noted the only weapons obtained by FERNANDEZ (MM-635-S) for BOSCH were reported in mylet 5/28/65 to Bureau with LHM attached. That communication indicates the MIRR claims to have acquired during period 5/7-12/65 one .57 mm recoilless rifle, 2½ pounds plastic explosive known as C-4, and one or more M-1 time delay devices.

For confidential info of the Bure au, MM-635-S acted as intermediary for BOSCH, and upon his request, in obtaining these weapons which were readily available in Miami.

On 4/11/66 MM-635-S advised he has not obtained additional weapons or explosives for BOSCH, but has indicated to BOSCH, for purpose of remaining in his good graces and aware of some of his plans, that he is in a position to obtain additional such supplies, if needed.

On 4/11/66 DAN WAGES, CIA, and FRANK ALLATORE, USAFAD, advised their agencies had no operational interest in the matter reported by CIA. On the same date, STANLEY SCHACHTER advised Customs is investigating the info reported by CIA in his 3/18/66 report.

Pursuant to Bureau instructions, Miami is conducting no active investigation concerning the matter reported by CIA. As Bureau is aware, BOSCH is in process of planning another raid, utilizing services of MM-639-S. Tentative plans are for this raid to take place Sunday, 4/17/66.

Miami is maintaining close contact with MM-639-S and U.S. Customs re this matter, and Bureau will be advised of any further pertinent info.
