SSC letter of 11/26/75, contained 28 requests for We previously have submitted 4 FBI memorande dated 12/8/75, 12/18/75, 1/6/76, and 1/7/76, responding to these requests. This memorandum responds to the remaining Items that have been outstanding and which are mentioned in this memorandum. It is pointed out that in regard to Item 15, Eduardo Guevara is the subject of New Orleans file 134-905, Bureau file 105-92106, which file was opened on 3/18/66, and closed by New Orleans letter to the Bureau, 8/26/66, on the basis that Guevara was a CIA contect and had been a CS Contact of that Agency since 1960. In regard to 16b, this has been coordinated with Inspector J. Allison Conely of the Inspection Division. He edvised that the Attorney General was not in receipt of enclosed Item 16b, which is material disclosing the Inspection Division's additional inquiries.
