noted GLEA advised he is not now, and has never been, employed by the U. S.Government in any capacity. He indicated he has been previously employed by the Government of Cuba, as reflected in the enclosed LHMS (He related he has, from time to time, furnished information which he considered to be of value to the U. S. Immigration Service, U. S. Secret Service, U. S. Customs Agency, and the FBI in New York City. OLEA is referred to in New York airtel dated September 30, 1965, (NY File 15-36970) (MM File 15-4762). He further advised that approximately ten months ago he received \$100.00 from the U. S. Secret Service in connection with an investigation involving the sale of gold.

It is to be noted that on November 22, 1965, AUSTIN HORN, CIA covert, Miami (protect), advised that LUIS CLEMENTE POSADA CARRILES was of operational interest to CIA. Also, HORN stated that their records reflected SERGIO SANCHEZ SUAREZ had formerly been connected with the JURE, and had made various trips to the coast of Cuba. JURE may have been, at that time, of operational interest to a U. S. Government Agency, Washington, D. C. SERGIO SANCHEZ is identical with Bureau File 46-48640.

In view of the fact that there are no concrete plans to possibly attempt to assassinate FIDEL CASTRO, no further investigation is being conducted in this matter.

It is further noted during the interview with CLUIS CLEMENTE POSADA CARRILES on November 30, 1965, POSADA indicated that he was closely associated with another U. S. Government agency whose identity he had been told not to reveal CPOSADA stated he had furnished all information regarding this matter, as well as any other information coming to his attention which would be of interest to the U. S. Government, to this other unnamed U. S. agency CPOSADA further advised he had been instructed not to furnish any information to any U. S. Government agency. He explained the FBI had not been specifically mentioned, but before furnishing any additional information in connection with instant matter, he desired to contact the unnamed agency and get their approval.
