the Attorney General of the United States in accordance  
with provisions of Sections 851-857, Title 50, United States

any application of the exception provisions contained in  
Sections 851-857, Title 50, United States Code is being left

NOTE: Subject is a defected agent of the Dominican Intelligence  
Service who was contacted by our New York Office on numerous  
occasions from 11/28/60 to 10/1/61. On 3/3/61 the Director  
excepted him from the requirements of Sections 851-857, Title 50,  
U.S. Code, which require that persons who have received training  
in espionage service of a foreign country shall register with  
the Attorney General. REC-6

On 11/21/60 the Department rendered an opinion that  
once an individual had been excepted from registration he could  
not, thereafter, be required to register for the same activities.

NOTE CONTINUED:

Subject is of no further value to us. Regarding such an individual, our policy has been to refer pertinent facts concerning him to the Department once the necessity for concealing his identity had expired.

We turned subject over [to CIA] <sup>(S)</sup> and since 10/1/61 he has been employed [in a covert capacity by that Agency.] <sup>(S)</sup> By directing above letter [to CIA] we are putting [that <sup>(S)</sup> Agency] on notice that any responsibility for exception of <sup>(S)</sup> subject from the provisions of the Registration Act now lies with CIA. <sup>(S)</sup>

Letter is classified "Top Secret" since it concerns a double agent operation of CIA and sets out agent's identity. <sup>(S)</sup> <sup>(U)</sup>
