By letter dated June 29, 1961, CIA advised It had received information from subject was supplying "Prezon," an Argentine newspaper, with material for publication. The newspaper was described as being anticommunist. CIA possessed no additional information on subject or "Pregon" and requested data regarding subject possessed by this Bureau for passage to

We had no information to furnish CIA upon receipt of their request and initiated inquiry to identify subject. Inasmuch as we have now developed background data concerning him we are furnishing same to CIA for passage to their sources. Also since we are requesting them to furnish us with any additional data they develop it is considered desirable to allow CIA to furnish this material to their sources rather than Legat. In this manner we will be assured that the source who is apparently in a position to know of subject's association with "Pregon" will have the results of our inquiry. Legat, however, should and is being alerted to instant matter. Evaluation memorandum is not being disseminated with report to CIA as CIA is the other Government agency mentioned in the details of the report.
