It is noted that page 2 of the above investigative report contains information that on a passport application dated 7 July 1956, Paris, France, Richard Thomas Gibson listed a Mr. Robert Snowden, 124 North Washington Street, Rockville, Maryland, as a reference.

It is believed that the above Robert Snowden is identical to Robert La Snowden, undertaker, whose current address according to the local telephone directory is 246 North Washington Street, Rockville, Maryland,

Herman Roscoe Talley, born 29 May 1916, Gaithersburg, Maryland, 3) a current Agency employee, listed Robert Snowden, 246 North Washington Drive, Rockville, Maryland, as a reference in 1952, and a copy of his undated Personal History Statement is attached.

The son of Herman Roscoe Talley, Herman Kenneth Talley, born 25 April 1940, Gaithersburg, Maryland Calso listed Robert L. Snowden, 246 North Washington Street, Rockville, Maryland, as a reference on an 11 March 1957 Personal History Statement. Herman Kenneth Talley (5) was a summer employee of this Agency in 1957. It is not known at this time whether either Herman Roscoe Talley or Herman Kenneth Talley are known to Richard Thomas Gibson.

In view of the above information, it would be appreciated if your Bureau would furnish this Agency any information contained in your files in regard to the Robert Snowden listed as a reference by Richard Thomas Gibson and/or the Robert L. Snowden listed by Herman Roscoe alley and son as a reference. REG. 32 105-93072-
