*Cuban Exile Activities -*

Information on the U.S. persons whose names appear on the attached document was obtained incidental to collection of information on terrorist activities.

1. The following information may not be released to foreign nationals, contractors, or contractor/consultants. The extraction and dissemination of the information is controlled by the originator. It is requested that no action be taken regarding it without prior approval of this office.

2. Reference is made to CIOL-0367-76, dated 2 November 1976, with subject title "Report Received by [redacted] on Activities of Cuban Exiles Possibly Involved in Terrorism." The source of that information, who is a sensitive usually reliable reporter, has subsequently provided the attached list of Cuban exile activists which accompanied the report received by the [redacted] from its contacts in Miami. The arrows and other markings on the document were apparently added by the [redacted] office.

3. No additional dissemination of the above information is being made.
