Now, Mr. Secretary, in the way which your understanding was of the expected degree of candor between CIA and the State Department, would it be your expectation that if <u>Mro Hersert</u> had known that other weapons had been passed to the same dissidents and they had stated that they intended to use those other weapons to assassinate Mr. Trujillo, that <u>Mro Merser</u> should have passed that information on to Mr. Berle?

Mr. Rusk. Under those circumstances, I would think the answer is yes.

I mean, one thing I'm sure of, Mr. Schwarz, and that is Mr. Berle did not write this memorandum on May 3rd, 1961 in preparation for a Senate investigation in 1975.

Mr. Schwarz. You believe it to reflect accurately what transpired?

Mr. Rusk. I have no doubt. It was sent to Mr. Coerr, Mr. New, Mr. Devine, in the Department of State, and I've known Mr. Berle for quite a long time and I would have predicted this would have been his reaction.

#### MEMORANDUM FOR THE RECORD

SUBJECT : Record and Related Policy Decisions on Passing Arms to Dominican Dissidents

1. The following is taken from a Memorandum dated 11 May 1960, Subject: Debriefing of Ambassador Farland:

"The Ambacsador began by saying that according to "Mr. Number Che", the leader of the Examinican Dissident princes, (when he did not identify), the dissidents need guns and arounition from the United States. In particular they need a small number of high-powered rights. The Ambaccador shid that he saw no problem in the purchase and delivery clandestinely of the arms to the dissidents. But he said, of course, this raises the question of whother the United States Government wants to engage in this activity."

2. On 21 June 1960 Anwassador Farland told for that (1)(4) he thought that an air drop would be the best way to colliver the arms to the Dominican dissidents. Appacador Farland shouched for the location of three possible sites for landing a light aircraft near Gludad Trujillo.

3. In a mosting on 23 June 1960 Assistance Secretary Rubotton told Col. J. C. Ming that the Government of the United States was prepared to provide the Seminican dissidents with a small number of emiper milles or other devices for the removal of key frujillo people from the scene.

4. On 29 Procenter 1960 the Special Croup approved a plan of covert action, to be lervely effected thrown former President of Costa Rica, Jose PIGUERES, and prividing for increased propagenda directed assimut Generalization fallifield, and for the financial support of selected calls groups. Additionally this approval included authorization for the CIA to make available to selected emile groups computations equipment and support necessary for these to develop a capability of infiltrating personnel and equipment into the Deminican Republic.

5. At 32 January 1961 meeting of this Special Group, Mr. Livingston Merchant stated that the Department of State folt that a limited number of small arms and other materials , should be made available for the dissidents inside the Dominican Republic. Mr. Thomas Parrott of the CIA said that he believed that thus could be accomplished securely by the CIA and that the plan would stipulate that the actual introduction of the materials into the Dominican Republic would be the responsibility of the Dominican dissidents thenselves. The decision of the Special Group was communicated to Consul Dearborn in Ciudad Trujillo, and in a letter dated 31 January 1961 to Mr. Frank Devine of the State Department, Consul Dearborn made the following remark: Whith regard to the delivery of the exotic equipment, my friends were of course delighted that such a decision has been made. hope that it will not be necessary to play down too long the question of actual delivery since they are carer and expectant and a too great tardiness on our part would only lead then to question our sincerity."

(1)(A)(B)In TRUI OKS2) dated 15 March 1961, GROOT OF GRAMMAN 6. Nobert Cura, made the following request: "1. For issue to Several dissident people Consul Deerbern requests three thirtyeight culiber Smith & Wesson special pistols or similar and three shall boxes curtridges. If sending amunition complicates problems, advice and us will try to get at iron the Whrines." The Deputy Director of Flans on 23 March 1961 approved this request and the CIA incodiately provided the requested material es the Stavier, One of these warpone was given to Jordi BRCOSA, a dissident leader, by Concul Bearborn, and the other two were passed as the Station to Lating Lowers and estimation in direct touch with the action element of the dissident organization.

7. On 28 March 1961 in TRUE OMES the Station requested (1)(A)(B)permission to pass times 141 Carbines, Cal 30 and supply of U. S. Naval personnel to be passed to the dissidents. : CIA Involvement in Cuban Counterrevolutionary Activities -- Arrest of Rolando CUBELA Sucades and Ramon Tomas GUIN Diaz

1. With reference to the Habana Prenza Latina news release of 5 March 1966, alleging CIA involvement with Relando CUBELA Secades and Ramon Tomas GUIN Diaz in counterrevolutionary activities, the following outlines the Appenent wer those two persons.

2. GUIN Free recruited by a CLA agent in Au Gaba as a Principal Agencies recruit agen-level military lea He has had no contact with CIA staff personnel.

3. CUBELA, the more important of the two men, has been in contact with this Agency during the period 1961-1965. The last Agency contact with CUBELA was in February 1965. He has had direct contact with several Agency officials and, in addition, is known to have been in contact with Cuban exiles, including Manuel ARTIME. Giddscontect-and relationship with both CUBELA and GUIN wearfor the consent respond of using them to collect intelligenceron whither activates and confective same conserve The Agency was not involved with either of these two men in a plot to assassinate Fidel Castro, as claimed in the Prense Latina news release, nor did it ever encourage either of these two persons to attempt such an act.
