Persuant to critic <sup>publications</sup> ~~statements~~ by former CIA employee James Wilcott that LHO was a CIA agent, Staff Investigator Harold D. Reap, interviewed the following ~~is~~ <sup>staff</sup> personnel to determine if there ~~total~~ <sup>collaboration</sup> for ~~the~~ Wilcott statements ~~had personal knowledge~~ relating to the Oswald <sup>CIA</sup> agent issue.

## CIA employees

The above individuals were selected for interview because of the position they held <sup>13-3</sup> at the time with the CIA at the [Tokyo] station <sup>13-3</sup> during the time ~~period~~ frame at 1959 to 1964.

James Wilcott ~~made~~ gave testimony in a closed hearing before the SCA that a CIA case officer ~~told him~~ stationed in [Tokyo, Japan] <sup>13-3</sup> told him that LHO was a CIA agent and ~~also~~ <sup>also</sup> mentioned LHO's crypto ~~machine~~ <sup>13-3</sup> The conversation ~~took~~ took place in the [Tokyo station] shortly after the word of the JFK assassination was received on 25 Nov 63. Wilcott ~~also~~ stated that could not recall the name of the case officer or the cryptomachine. Wilcott also advised that considerable conversation <sup>13-3</sup> took place among CIA employees <sup>at the time</sup> concerning the Oswald-CIA agent issue.

The basic questions asked of the CIA employee selected were as follows

- (a) Have you ever seen written documents which could indicate that LHO was a <sup>intelligence</sup> CIA agent or a source of information?
- (b) ~~Have~~ <sup>Where</sup> you ever heard advised orally that LHO was an agent?
- (c) Have you ever heard conversation or heard <sup>conversations</sup> speculation that LHO was a CIA agent or intelligence source for any government <sup>service</sup> ~~agent~~?
- (d) Were you in a position to know if LHO was recruited as an <sup>CIA</sup> agent during his tour of duty with the military in Japan.

- (2) When was the first time you ever heard the allegation that LHO ~~was~~ <sup>may have been</sup> a CIA agent.
- (3) Did you know James & Edie Wilcott in <sup>13-3</sup> [Japan?]

~~None of the~~ <sup>all</sup> individuals interviewed stated they never saw any documents nor heard any information that LHO was a CIA agent while stationed in Tokyo. Only after ~~their departure~~ <sup>the</sup> critic publication and the Garrison investigation in the late 60s were they ~~so~~ <sup>are</sup> aware of the ~~patched~~ allegation.

Subjects 2, 7 & 8 expressed belief that LHO ~~could~~ <sup>may</sup> have been recruited by the KGB during his tour of duty in Japan. They based their belief on the fact that during the period <sup>13-3</sup> of time that LHO was in Japan, the CIA [Station] in [Tokyo] had identified a KGB program specifically ~~described~~ <sup>designed</sup> designed to recruit U.S. military personnel in Tokyo. However they had no information that the recruitment of LHO by the KGB did in fact take place.

Subject Jerome E. Fox was ~~specifically~~ one person who Wilcat could remember ~~that~~ <sup>with who</sup> he had conversation ~~with~~ concerning the speculation that LHO was an agent for the CIA. The conversation supposedly took place in <sup>13-3</sup> [Japan] after the information <sup>was received</sup> that LHO was the assassin of JFK. Fox advised investigator Leap that he was in the U.S. at the time of assassination on 23 Nov 63. Fox's CIA personnel reflects <sup>13-3</sup> he was transferred from the [Tokyo station] to the U.S. in 1962.

Subjects 2, 7, 8, 9 and 11 all thought they would have known if LHO had been ~~recruited~~ recruited as a CIA agent while he was in Japan. All the subjects worked with <sup>13-3</sup> the SR Branch of the [Tokyo station] and theoretically ~~would have~~ one of them would have handled or had knowledge of the recruitment. All thought if Oswald had been recruited without their knowledge it would have been a rare exception to the working <sup>13-3</sup> policy and guidelines of the [station].
