Dear L.J.:

As you know, the Committee is winding down and the decision has been made to terminate your services as of Oct-tober 31, 1978.

You have been off the Committee payroll since March 1, 1978 due to duplication of salary payments from the New Orleans Police Department.

The following is how I have calculated the Committee's salary settlement with you:

You were hired July 5, 1977 at a salary of \$24,000 and taken off the payroll February 28, 1978. Your W-2 statement for 1977 gave a salary of \$11,815.27 from the New Orleans Police Department. The monthly amount would be \$984.61 (\$11,815.27 - 12). Prorating this amount would give \$7,745.60 while on the payroll of the Committee. (\$984.61 per month for the period July 5, 1977 to February 28, 1978).

You have been due \$1,015.39 per month from the Committee since March 1, 1978. (The difference between your Committee salary of \$2,000.00 per month and \$984.61). Dividing \$1,015.39 into \$7,745.60 (the overpayment referred to above) would carry you seven months and nineteen days or through September 19, 1978.

Accordingly, you would be due a gross salary of \$1,387.70 for the period September 20-October 31, 1978 (at \$1,015.39). However, because you completed a year of service on August 1, you were entitled to a 7% salary increase or \$1,700.00 annually. This would provide an additional amount of \$425.00 for the period August 1 - October 31 so the total amount due you would be \$1,812.70.

Further, recognizing the difference between your monthly income from your W-2 of \$984.61 and that of \$821.00 stated as your base pay by your commanding officer, I am recommending that the Committee settlement be in the gross amount of \$3,000.00.

This will be accomplished by restoring you to the payroll for the period October 16 to November 30 at a gross monthly salary of \$2,000.00 (\$24,000.00 annually).
