EXPERIENCE

January 10, 1964 sworn into the Baltimore City Police Department - finishing  
3rd in standing of 27 graduates. Thereafter assigned to the Southeastern  
District in uniform patrol that covered high crime areas. During this as-  
signment I handled all types of felony and misdemeanor investigations and  
arrests.

December 1967 transferred to the Criminal Investigation Division and assigned  
to the Vice Control Unit. In this capacity was assigned to undercover work in  
the areas of prostitution and gambling violations. While in this assignment,  
I kept a low profile and learned to develop sources of select confidential  
information.

In May 1968 was promoted to Detective Patrolman and re-assigned to the Crimes  
Against Persons Unit - Homicide Squad, which is my present assignment. While  
in this division, I have personally investigated in the excess of 225 homicides  
and have been actively involved with another 150 homicide investigations. I  
have also conducted hundreds of investigations into the areas of questionable  
death, suicide, serious assault, kidnapping, armed robbery, extortion, threats  
of death and hostage situations. For a period of about four years, have also  
investigated numerous sex related offenses such as rape, perverted practices,  
etc.

As a result of these investigations, I have testified in the Municipal Court, Criminal Court Supreme Bench, and the Grand Jury systems in the City of Baltimore and State of Maryland. On most occasions, the Court recognizes me as an expert in the field of homicides and related death investigations.

During my assignment in the Homicide Squad, I have acted in the capacity of field supervisor for about 3 1/2 years, supervising 5 to 7 investigators and their assignments. Have also had the experience of acting undercover while with the unit and on two occasions I was hired as a paid assassin. During these operations I worked with several forms of electronic equipment and became familiar with it.

I am acutely aware of how to search crime scenes; recover and preserve evidence; examine bodies; interrogate suspects; locate and interview possible witnesses; take full and formal affidavits and all other areas of homicide investigations. I furthermore have written and have been named the affiant on numerous search warrants and seizure orders.

It has been my duty on occasion to travel into other states and jurisdictions and take custody of fugitives from justice and return them to this city to be criminally charged.

During my tenure as a law enforcement officer, I have handled numerous line-ups, surveillances, and details for the protection of suspects, informants and co-operative witnesses.

I have a full training background in the area of handguns, shotguns, rifle and tear gas devices.

#### TRAINING

Have completed the "Francis Lee Glasner" Homicide Seminar, held at the Medical Examiners Office, Baltimore, Maryland, under the direct supervision of Dr. Russell Fisher.

Have also attended and completed a "Federal Bureau of Investigation" seminar on "Homicide and Sex Mutilation", held in Washington, D. C.

Furthermore, I have conducted and attended numerous training classes and procedure lectures held by the Baltimore City Police Department.

Since becoming a member of the Baltimore City Police Department in January 1964, I have been awarded the following commendations and citations:
