Interview: (Synopsis)

Phillip Geraci, was in Carlos Bringuier's store when LHO came in and offered his Marine manuel.

Subject reiterated his Warren Commission testimony, changed one point--subject states Vance Blalock (whereabouts unknown to date) mentioned that LHO asked Carlos Bringuier if he was a member of the (Coşa Noştra)--subject feels the name asked was Casa Roca, the store operated by Carlos Bringuier. Subject was a C.A.P. cadet for approximately one (1) year--62-63, didn't know David Ferrie, and had little or no contact with senior group headed by Ferrie. Subject viewed photo book, supplied by the Committee, numbered in sequential order #1-110, with photo #72/73 missing--identified #57, LHO.
