MM 665-C on 2/26/62 advised CHARLES TOURINE (Miami File 92-106) and JOSEPH NESLINE are not in any bookmaking operation in Miami this winter season. He stated that he was told TOURINE and RUGGIERO BOIARDO, aka "BOOTS", from the Newark area, had dinner together at Tony Sweet's Fish Market Restaurant, North Bay Village, Fla., on 2/20/62 or 2/21/62.

PCI JOHN OLIVER on 3/1/62 advised that TOURINE left the Miami area on 2/27/62, destination unknown to him.

MM 665-C also advised he learned MANNY SHERMAN, a card cheater, operates with MAX EDER (Miami File 92-467) in the card room at the Fontainebleau Hotel, Miami Beach, and that SHERMAN is paid \$50 a night for his work.

Mrs. ANN DRAHMANN, ex-wife of MICHAEL COPPOLA (Miami File 92-101) confidentially advised on 2/22/62 that in the past, PHIL LOMBARDO, aka "COCKEYED BENNY", PATTY ERRA (Miami File 92-648) and individual called "BUCKALU" (phonetic) and ANTHONY SALERNO (Miami File 92-406) acted as couriers for MICHAEL COPPOLA, bringing funds from New York City to Miami. She also advised that COPPOLA had 15 percent of the bookmaking operation which MAX COURTNEY, FRANK "RED" REED and CHARLES BRUDNER operated previous winter seasons out of the Eden Roc Hotel, Miami Beach.

She further advised that MAX EDER, about every 10 days or each other week, would deliver \$10,000 or more to COPPOLA at COPPOLA's home. In addition, she related EDER would call COPPOLA when he made a shylock loan to secure COPPOLA's okay and that a person borrowing \$10,000 would have to pay \$1,000 a month interest until the loan was paid out.
