DANIEL SULLIVAN, Operating Manager of the Crime Commission of Greater Miami, on 4/4/62, advised that he had received information that ANTHONY STEFANO RANDAZZO (Miami file 92-403) has a fish business located 2 doors from the Lucky Bar on N. W. 27th Ave., North of 7th Street, Miami, Fla. He stated he understood raw sea food and cooked sea food could be taken out or eaten there.

MM 509-C on 3/27/62, advised that he received information that BENNY SHERMAN, a bookmaker who was arrested several years ago in a raid on the North Dade Civic Club, Dade County, Fla., is supposed to start bookmaking on motel strip for HYMAN MARTIN, (Miami file 92-218) as soon as the major basebal teams begint their regular season.

This source also advised on 3/27/62, that he received information that ALFIE MART (Miami file 162-44) was recently ejected from the Gulfstream Park Race Track, Hallandale, Fla., as a bookmaker, because MART, when questioned by the track detectives became beligerent. He also received information that an individual known as PETE (LNU) aka "Snake Eye Pete", a bookmaker recently began working for MART as a bookmaker at Alfie's Sundry Store, Lincoln and Alton Rd., Miami Beach.
