[As previously advised] Giancana the Chicago La Cosa Nostra boss was reported to be in Mexico and had applied for immigrant status in that country. Chicago sources report (u) Giancana has not returned to the Chicago area to date. A Philadelphia informant now advises that Phyllis McGuire is presently at an unknown location in Mexico with Giancana. She reportedly left for Mexico shortly after finishing a singing engagement in Washington, D. C. Investigation being conducted to verify this information. (S) (A) (u)
