CRIMINAL INFORMANT COVERAGE

The following informants are being utilized in securing information relative to the captioned subject:

CG 6132-C knows ALEX and has observed him in the recent past frequenting a local restaurant with the other top hoodlums. The informant advises he knows ALEX casually and information contemplated will result from direct observation of ALEX and conversations with his associates.

PCI JEAN HALL, prostitute, has met ALEX and knows him casually. She claims that she is acquainted with close associates of ALEX. Information is anticipated through contacts with associates of ALEX.

PCI SAM NUKES, who frequents gambling games in the territory of Chicago, purportedly under the control of ALEX, is attempting to secure factual information as to the actual control of those gambling activities.

Further informant coverage is contemplated through attempted development of informants at places where ALEX is known to meet other hoodlums such as Mike Fish' Restaurant in Chicago. Utilization of previously used informants will be used where such efforts are warranted.

Attempts will be made to establish informant coverage at ALEX' residence through service personnel making deliveries. All informant information received will be evaluated in an effort to develop informants that will be able to report more direct information as to ALEX' activities and associates in furtherance of the Top Hoodlim Program.
