JAMES C. POST, neighborhood source, 216 Highland Avenue, New Kensington, Pa. (telephone number Edison 5-7733) on May 27, 1958, advised SA DOUCE that he had just returned from his business trip to the Orient and learned of the FBI's interest in SAMUEL MANNARINO from Mrs. POST. He stated that he would be happy to give his assistance to the FBI and would be especially alert for any evidence that would indicate that GABRIEL MANNARINO might be visiting SAMUEL MANNARINO's home.

At New Castle, Pa. (Lawrence County)

Will at the former location of Al's Beer Garden attempt to develop information concerning the present whereabouts of JIM COWARD who is reported to be cooperative and who could furnish the location of a hunting lodge owned by the MANNARINO brothers. For background information refer to heading of Places of Amusement and Hangouts Frequented in the attached report.

At New Kensington, Pa. (Westmoreland County)

1. Will maintain regular contact with PCIs MIKE ZERVOS, WALTER J. SHARKEY, PG 545-C and PG 564-C for the purpose of developing current information regarding the MANNARINO brothers' legitimate enterprises, criminal activities and associates.
2. Will recontact Mr. and Mrs. MARSHALL HOLT, neighborhood sources, at 536 Charles Avenue and Mr. and Mrs. JAMES C. POST, neighborhood sources, at 216 Highland Avenue.

4. Will report investigation being conducted by the Los Angeles Office to develop information regarding the MANNARINO brothers' association with STEPHEN ZOCCOLI who according to the Los Angeles Police Department reportedly made an unsuccessful attempt to enter the bar business in Northern California several years ago because his association with the MANNARINO brothers came to the attention of the local police. Investigation requested in Pittsburgh airtel to Bureau, 4/30/58.
5. When information is received from Philadelphia will document Philadelphia top hoodlums JAMES OSTICCO and ANGELO SCIANDRA who according to former commissioner of investigation, New York State, were in GABRIEL MANNARINO's automobile at Apalachin, New York, on November 14, 1957.
6. Will document top hoodlum RUSSELL BUFALINO when information is received from Philadelphia. Investigation requested in Pittsburgh airtels to Philadelphia, 5/17 and 20/58.
7. Will recontact PCI ALFRED CHARLES ZAPPA concerning the report that the MANNARINO brothers have a numbers operation at Lloyd's Limited, 1926 Murray Avenue, Pittsburgh, involving DAVID LAWRENCE and SONNY (LNU), who is probably identical with SONNY CINSUTTI, Shylock for the MANNARINO organization in New Kensington.
8. Will follow and report SAMUEL MANNARINO's physical condition.
9. Will report investigation being conducted by the Philadelphia Office at the American Export Lines to determine whether GABRIEL MANNARINO made a reservation on the "Independence" for May 6, 1958.
10. Will report results of supplemental investigation being conducted by the Washington Field Office at the Passport Division, Department of State, to determine whether GABRIEL MANNARINO has requested permission to travel abroad since stop was put into effect on February 3, 1958.
