agree to let the agent view the note for a few moments. He advised that the original of the note was in a safety deposit box and could be obtained for court by issuing a subpoena to him as custodian of the note.

The copy of the note, which was payable to J. FOLSE ROY for \$300,000.00 bore the signature of CARLOS MARCELLO. On the back of the note was a statement advising that the sum of the note was backed by certain coded security, stocks in Churchill Farms, Inc. and in Bayou Verret Land Company, Inc. The sum of the note was further backed by a promissory note dated 11/25/60, signed by VINCENT C. RODRIGUEZ and made payable to FLORENCE MONTALDO which CARLOS MARCELLO apparently had bought from MONTALDO. The back of the J. FOLSE ROY note was notarized by M. H. CONNOLLY.

MAGEE advised that RODRIGUEZ was ROY's attorney, but FLORENCE MONTALDO was not known to him. He believed M. H. CONNOLLY was MARY CONNOLLY.
