

ANGELO BRUNO, AKA; AR. DAILY RAD. PH 623-C* ADVISED ANGELO BRUNO SUMMONED FRANK MONTE TO HIS OFFICE AND IN THE PRESENCE OF PHIL TESTA CRITICIZED MONTE FOR NOT BRINGING TO HIS ATTENTION SOONER THE TRIP IGNATIUS DENARO (IDENTIFIED BY BRUNO AS A ORGANIZATION MEMBER FOR THE PAST 30 TO 35 YEARS) MADE TO THE NEW YORK COMMISSION WITH A "BEEF" OVER BRUNO'S HEAD. SAMLLNU IN THE RECENT PAST OFFERED MONTE 25% OF A ZIGANETTA GAME IN WHICH MONTE ACTED AS DEALER. DENARO DECLARED HIMSELF IN AGAINST THE WISHES OF SAM FOR 25%. SAM IS A MEMBER OF "ANOTHER FAMILY."
