

# A. PERSONAL HISTORY AND BACKGROUND

### 1. Residences

On May 23, 1960, FG T-1, who has furnished reliable information in the past, advised SA THOMAS G. FORSYTH, III, that SAMUEL MANNARINO continues to reside at 201 Highland Avenue, New Kensington, Pa., and that GABRIEL MANNARINO continues to reside at 540 Charles Avenue, New Kensington. PG T-1 pointed out that while GABRIEL MANNARINO resides at the foregoing address, he does not spend very much time in the New Kensington area as compared with a few years ago.

### 2. Status of SAMUEL MANNARINO's Health

On May 23, 1960, PG T-1 advised that all of the information he has received recently indicates that SAMUEL MANNARINO is approaching the final stages in his battle with his abdominal malignancy. PG T-1 said that in his estimation the next few months will see a gradual decline in strength and ultimate demise of MANNARINO.

### B. ASSOCIATES

It has been reported previously that six of the MANNAHINO associates were convicted and sentenced in the United States District Court, Western District of Pennsylvania, Pittsburgh, Pa., on February 4, 1960, in the case captioned, "STUART SUTOR, ET AL; INTERSTATE TRANSPORTATION OF STOLEN PROPERTY; FEDERAL PIREARMS ACT; NEUTRALITY MATTER; THEFT OF GOVERNMENT PROPERTY; CONSPIRACY". Although arguments on appeal before the Third Circuit Court, Philadelphia, Pa., have been concluded, no decision regarding the appeal has been handed down as yet.

## 1. DANIEL HANNA, aka., Speedo

On May 9, 1960, PG T-2, who has furnished reliable information in the past, advised that SPEEDO HANNA and his 19 year old paramour, JUDY SMITH, are sharing a second floor apartment at 731 Anderson Street, New Kensington. He pointed out that this building consists of four apartments, another of which is occupied by JOHN FONTANA, top lieutenant in the MANNARINO organization. PG T-2 said that JUDY SMITH's parents are frantic over her romance with HANNA, and JUDY's father and her two brothers, not
