Reference is made to the report of Special Agent THOMAS G. FORSYTH, III, Pittsburgh, March 16, 1962.

There follows a brief characterization of informants used in referenced report:

- PG T-1 is a Westmoreland County, Pa., businessman, who has been used as a consultant by the MANNARINOS in some of their legitimate enterprises.
- PG T-2 is a New Kensington, Pa., numbers writer, formerly connected with prostitution activities.
- PG T-30 is a businessman in Allegheny Township, Westmoreland County, Pa., whose business brings him into contact with many of the area inhabitants and leaders.
- PG T-32 is a former racketeer from Mercer County, Pa.
- PG T-35 is a student who has worked with racketeers and gamblers in Vandergrift and Oakmont, both Pennsylvania.
- PG T-39 is a Pittsburgh, Pa., gambler and club operator.
