(possibly 2000) shares of stock of Jubilee Iron Corporation. Information was received from the Royal Canadian Mounted Police, Ottawa, Canada, that L. J. Forget and Company has a reputable standing in Montreal financial circles and that this firm handled the sale to ROSELLI of 2000 shares of Jubilee Iron Corporation in the latter part of April, 1965, for a price of \$2.75 per share and later sold the 2000 shares at a price ranging from \$4.10 to \$4.75 per share. RCMP advised that ROSELLI had been vouched for to Forget and Company by a GEORGE PALLAY, 345-8th Avenue, New York City, who also maintains a residence address at the Friars Club in Los Angeles; that PALLAY is known to be a close friend of JOHN C. DOYLE, who is Chairman of Jubilee Iron Corporation, and that DOYLE was recently convicted in the Eastern USA as a result of unlawful share sales in the USA.

On 6/28/65 ROSELLI deposited a check for \$4,500. to his personal account at the Fidelity Bank in Beverly Hills, California. This check was drawn on the Exchange National Bank of Chicago, which is the bank used by LOUIS J. LEDERER to pay ROSELLI a similar amount each six months for the sale of Nevada Concessions, Inc. by ROSELLI to LEDERER in 1958.
