The NYO is not incorporating this information in instant report inasmuch as it does not appear pertinent to this investigation at this time.

A review of NYO indices reflects 2 references believed to be identical with WILLIAM BAKER of Croton-on-Hudson NY, to whom subject apparently placed a telephone call. However, these references are not derogatory and appear to concern legitimate window cleaning contracts made by WILLIAM BAKER with Czechoslovakian establishments in this country. For the information of the Bureau, these references are as follows

1. NYlet to Bu, dated 4/8/57, captioned CHICAGO CLEANING CONTRACTORS CORPORATION; IS - CZ".

2. NY report of SA JOHN S. MC COOL, dated 3/17/50, captioned "CZECHOSLOVAKIAN DIPLOMATIC ACTIVITIES IN NEW YORK; IS -[R and CZ" (NYfile 100-93422-124) (The last paragraph on Page 3, thereof, reflects that one WILLIAM BAKER of the Ability Window Cleaning Co., 156 East 42nd St. NYC, was in Contact with JAN KYJOVSKY, then Czechoslovak Consul General, in NY.

The auxiliary offices which conducted investigation, set forth in this report, advised of no derogatory information concerning the subscribers whom they identified
