It is recalled that a 1962 Cadillac, bearing 1963 Ontario license 453-104, was observed on several occasions at the residence of subject.

MM T-12 reported that this license was <u>MAY MAPS</u> listed to Antilla Investments, Limited, 318 Rezdale Boulevard, Rexdale, Ontarion. Officers of this company, according to MM T-12, include <u>THELMARBENNY</u>, the wife of <u>BENJAMIN</u> <u>BENNY</u>, also known as <u>Benjamin Zaratsky</u>. \On a previous occasion, in 1962, when he visited Miami, <u>BENJAMIN</u> BENNY was interviewed by Bureau Agents, and admitted that he has known subject since prohitition days. G-\

BENNY said that in the old days he sold liquor to American bootleggers who came to Canada to purchase it. BENNY Resides in Canada, and is associated with various business interests in that country. He has a criminal record in Canada, dating back to 1919, when he served seven months imprisonment on three charges of theft. In 1932, he was convicted on a charge of assault and was given a sentence of six months definite and six months indefinite.

It is recalled that an automobile, registered to one E. K. TODD, Ojus, Florida, was observed by the Miami Police Department in the area of subject's residence.

On July 23, 1964, Mr. B. K. TODD, 2480 NE 184th Street, Ojus, Florida, who is employed as a bulldozer operator by Curcie Brothers Construction Company, Hallandale, Florida, advised that he does not know the subject.
