IN ONE INSTANCE BILLY DAUBER IDENTIFIED AS CG SIX SEVEN ZERO ZERO DASH C AND ALL OTHER INSTANCES ALLUDE TO CG SIX FIVE EIGHT EIGHT DASH CTE BEING IDENTICAL

TO HAROLD LURIE CLOSE CONFIDANT AND BUSINESS ASSOCIATE OF FELIX ALDERISIO. DISSEMINATION OF THESE FIVE AIRTELS UNDOUBTEDLY WOULD COMPROMISE THESE LIVE SOURCES AND PLACE THEIR LIVES IN SERIOUS JEOPARDY
